-Robin Hessel has an advertising idea of making a video to submit to Griffith Films who run channels 6 and 9. She will continue to research, to include finding a charity for the GMO to support.

Awards: Nancy Litsch brought a sample of the 40 canvas grooming carriers to use as end of year awards. Robin and Chris will see about a logo embroidered on them, or a patch created

-Discussed what we could do to make the two championship shows in October special in order to attract out of state participants. Agreed on neck ribbons and belt buckles, and will consider other ideas.

-Discussed helping out our show volunteers when they are working a long day by giving them more breaks and looking for more volunteers by calling for them in the newsblasts. Discussed an end of year thank you gift for all volunteers to be awarded at the November AGM. **Newsletter:** Nancy Spring is doing a fantastic job on the newsletter! Tamera Mayo will resume the newsblast emails about two weeks after the newsletter comes out, as a reminder of upcoming activities and save the date announcements.

-Newsblasts will be sent out via Mailchimp to all members and people who have signed up for the newsletter, in order to be able to do analysis of how many people read it, how many readers then went to the website, etc. Tamera will send the newsblast to Janet Cagle, who will put it on Mailchimp for distribution.

- Working Equitation: Tamera Mayo asked for certificate of insurance for the B rated show set for Sheridan Stables on June 9. Stacia Wert-Gray will provide.
 -Plans were discussed to streamline the set up and clean up of WE equipment at upcoming shows.
- **Treasurer:** Stacia Wert-Gray reported that there is about \$3200 in the account. We owe \$2000 for the porta potties for the year and \$1000 for insurance. Hoping to generate about \$2000 at the February show since there are 90 rides scheduled.
- Education: Wellness Spa Day planned in conjunction with the March 31 show. Free lunch to be provided for owners who participate in services. Stations to be available include: shots, Coggins tests, dental services, chiropractic, acupuncture, saddle fitting, cranial adjustments, and a water treadmill. Robin Hessel is coordinating and scheduling.
 -Annie Houchin is working on the Janet Foy New Test Symposium. Plan now is to charge auditors, but have lunch be included, and to have no charge to demonstration riders.
 -Janet Cagle will be doing a Goal Setting workshop at Valley View on February 24. Discussed format and food.

Items for discussion:

-Stacia Wert-Gray asked for a discussion on having Breeders Challenge in hand and under saddle classes at shows in September and October to allow horses to qualify for Region 9 championships. If there is a Breeders Challenge at regionals, we will consider. -Arab show has been scheduled for Sunday, May 14, with Ryan Bell "r" from Atlanta as judge.

-Discussed a policy on horses coming in to show who are showing signs of illness such as strangles. They will need to be separated from all other horses in an emergency isolation stall.

-Summer AGM will be scheduled in conjunction with the adult camp in August, hopefully with Melissa Creswick.

-End of year AGM, awards and freestyle fiesta is scheduled for November 17. -Discussed having a professional's page on the website, free as long as they are members. Links will be added to other GMOs.

-Discussed policies related to new activities to be added to the schedule, in order not to saturate the market. Decided to take them case by case in order to avoid calendar conflicts and overload.

-Discussed "Barn Angels" program, young riders to help competitors unload, groom, feed, etc. at shows in order to earn tips for their Junior Camp in June. Will make lanyards for the kids to wear, a sign at the check in table to advertise, and will need an adult to supervise and explain the program to competitors as they arrive.

-Discussed signs needed for competitors to remind them not to dump water in stalls as they leave, and to put hay out by the manure truck rather than leave it in the stalls.

Central Plains Dressage Society I Meeting Minutes December 16, 2018 5519 York Road, Stillwater, Valley View Equestrian Center

The meeting was called to order by Chris Cashel at 5:20. A quorum was present. Present: Chris Cashel, Stacia Wert-Gray, Annie Houchin, Nancy Eytcheson, Amy Mullins, Robin Hessel, Christina Harmon, Bud Patterson, Chloe Patterson

Minutes from November AGM and board meeting were approved. Motion made by Annie Houchin, seconded by Christina Harmon. Unanimous approval.

Committee reports:

Treasurer

-Stacia Wert Gray reported that the current bank balance is \$2196. A full report on the 2018 Profit and Loss for CPDS will be available on the CPDS website.

-The 503(c)(3) has been approved. Amy Mullins will add the information with numbers and W-9 to the website, and Stacia will update the Horse Show Consulting website.

Membership

-Christina Harmon reported that in addition to a good start on renewals, we have 23 NEW members. She is working on some challenges with the membership application online. Stacia Wert Gray and Amy Mullins will be helping out with clarifying the directions and links.

-Bud Patterson suggested investigating having a booth at the Payne County Home and Garden shows and County Fair to promote membership and generating interest in the sport.

-Creation of a new member packet was discussed as well as what to include. Addresses and directions to show and clinic locations, maps of amenities at show facilities (such as restrooms, water, office, etc), list of member professionals with contact information, board members and contact information, and possibly articles that will also be in the newsletter, such as "What to Expect at Your First Horse Show" and "How Volunteering Will Help You Learn How to Show."

Awards

-In response to member requests, the Year End Awards Program has been changed. Stacia Wert Gray gave a report on the changes, which include:

*Awards are now based on a median percentage of the top seven scores in each category, rather than using accumulated points.

*Categories include recognized Dressage shows, recognized Western Dressage shows, east area schooling shows, and west area schooling shows.

*Scores are only to be earned at CPDS shows by CPDS members, although scores earned before becoming a member will count as long as the rider earns the scores by the new April 1st deadline.

*A minimum overall median score of 57% is required to earn a CPDS year end award

-Christina Harmon will again pursue breed awards, and Stacia Wert Gray will write an article for the newsletter on the AQHA point program already in place

Shows

-A full list of all the divisions in each category of show, as well as a full show calendar will be available on the Horse Show Consulting website as well as the CPDS website.
-Increasing the number of volunteers at our shows was discussed. Annie Houchin suggested a volunteer training day would be helpful as well as fun. Amy Mullins will get requests for volunteers on the CPDS website and a link to Horse Show Consulting entries. Places to request volunteers was discussed, including 4H, Girl Scouts, Block and Bridle, homeschoolers with a volunteer component in their program, and people requiring community service hours from the DA's office.

-Annie Houchin will coordinate a volunteer training day for the East, and Chris Cashel will coordinate for the West.

Newsletter

-Articles suggested include "What to Expect at Your First Show" (Nancy E), and "How Volunteering Will Help You Learn to Show," "What CPDS Can Do for You, and What You Can Do for CPDS," a recurring monthly article on Horse Health Tips and ordering information for club logo clothing.

New Business

-Discussion about judges' qualifications at schooling shows. Janelle Williams, Deryn Stewart, and Robin Hessel volunteer their time for the first three schooling shows. Janelle Williams is the only one not yet an "L" judge, but she is a FEI rider, and has donated her time for over ten years as a schooling show judge. A motion was made to grandfather Janelle as a volunteer schooling show judge, and to require all other schooling show judges to be "L" judges, by Chris Cashel and seconded by Amy Mullins. Unanimous approval.

-Chris Cashel will investigate a CPDS window decal with the Fun-Friendly-Forward logo. -CPR training days were discussed. Chris Cashel will look into.

- AGM changes were discussed, including moving the Freestyle Festival (Dinner and Dancing Under the Stars) to a summer date, inviting the community to view. Winter AGM and catered End of Year Awards to be held at the Church in Stillwater where the Summer meeting was held. Bud Patterson volunteered to be auctioneer for fund raiser donations.

*Summer Camp activities and format

*Communications on the websites, Facebook, and the newsletter, to include a suggestion box

*Newsletter article submissions to Nancy Spring need to be in for publishing the first week of the month
