WDAA Horse Lifetime Performance & Award Program

WDAA supports a Lifetime Performance & Award Program. This is a point-tracking system awarding cumulative milestone achievements to horses competing in Western Dressage. Enrolled horses earn points by competing in tests and rail classes at WDAA recognized shows. Class placings and percentages are converted to a point system, which follows the horse as they travel up the levels on their journey.

The program was designed to be approachable and realistic for every horse and rider, regardless of their stage of training. The Lifetime Performance & Award Program follows the WDAA mission statement, values the partnership between horse and rider, and encourages a systematic education developing both the physical and mental abilities of the horse. The program does not require extensive travel nor significant financial investment; instead rewarding training, participation and performance. Points follow the horse and transfer to new owners.

The result is a record system celebrating attainable goals that further the relationship of horse and rider within the Western Dressage system. It's all about the Journey - from your first show, to your WDAA Register of Merit, to WDAA Supreme Champion. AQHA Western Dressage Program

AQHA members should check with AQHA regarding nomination of their horses with AQHA to be eligible for awards or points under the AQHA rules. This show is recognized by the AQHA, and scores will be reported to AQHA for those who declare their AQHA membership; the show will also pay to AQHA the \$8.00 per AQHA horse/rider combination, but it is the sole responsibility of the competitor to ensure they have completed the proper paperwork with AQHA for scores to be credited toward awards or points.

Competition Rules

- A. **Bridle Numbers:** All horses (competing and non-competing) must wear show numbers when out of stall or not tied to trailer.

- A. **Dogs:** Dogs are allowed on the grounds but must be on a leash or restrained at all times. They are not allowed near the show ring or warm-up ring. They must be quiet and mannerly.
- B. **Rain Plan:** Warm up is inside. Show arena is outside. In the event of rain and footing becomes an issue, the show committee may place the show "on hold" until the rain passes or may move the show ring inside to the indoor arena which is 18.5 meters wide. Should rain become heavy or we experience lightening, we will allow the next 5 horses on the schedule to warm-up indoors for 15 minutes. Those horses will then ride their test. This will cause the show to run late. Listen to the announcements for updates on warm-up and ride times.
- C. **Attire**
Required:
 Suitable western hat. Protective headgear may be worn without penalty (See GR801) and is STRONGLY recommended.
- Long-sleeved shirt with any type of collar: short sleeves may be worn at the discretion of the judge
 - Trousers, pants, a one-piece long sleeved equitation suit provided it includes a collar.
 - Boots with distinguishable heel.
- Optional:**
- Necktie, kerchief, bolo tie or pin.
 - A vest, jacket, coat and/or sweater.
 - Spurs. Western style, with or without blunt tines, English dressage style, roller ball, and blunt bumper spurs are permitted. Rowels must be vertical. Spurs with sharp tines are not permitted.
 - Chaps, shotgun chaps, chinks, armitas, or split riding skirt.
 - Protective headgear is acceptable; not required to be of Western style. BOD 6/28/21 Effective 12/1/21
- D. **Horses Not Competing:** Non-showing horses are allowed on the grounds if space is available. The owner must fill out an entry form and pay office, stall, and non-competing horse fees, but no USEF drug fee.
- E. USEF membership is required for the trainer of record. A parent of a junior rider is no longer able to sign as trainer without a USEF membership. In other words, the trainer must be a USEF member and current on Safe Sport training.
- F. **Sharps Containers:** Competition management shall place at least one sharps container in each stabling area for the disposal of needles and other disposable sharp instruments. Competition management may fine any individuals including trainers, owners, exhibitors or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. If local law has different requirements, local law prevails.
- G. **Other:** Every class offered herein which is covered by the rules and specifications of the current rules and of the current rulebook will be judged in accordance therewith.

Entries, Scheduling, and Scoring

A. General Information:

- **USEF Membership:** This is a USEF lite show. **NO USEF memberships, non-member fees, or horse registrations are required to compete in this show except for the person signing as trainer who MUST be a USEF competing member and current on Safe Sport training. If you are interested in accumulating USEF Horse of the year points, provide the USEF number for horse, owner and rider. Shows are eligible for ½ USEF pts. Please provide your USEF number if you are a member.**
- **WDAA Memberships:** All owners and riders competing to qualify for WDAA lifetime points **MUST be a member of WDAA** to be eligible for WDAA lifetime points program. You may learn more about the lifetime points program and about membership at www.westerndressageassociation.org. As a USEF "Lite" show, this show is eligible for DOUBLE WDAA lifetime points.

- AQHA Memberships: Those with AQHA membership who wish to qualify for AQHA awards are responsible for proper registration with AQHA to be able to earn points at this show. The show will submit \$8.00 to AQHA for each AQHA member; this is a required processing fee per AQHA horse/rider combination
- **Multiple Riders** - Horses may be ridden by multiple riders and may be ridden at different levels, but a horse may not be entered in the same class, even if ridden by a different rider.
- **Each horse/rider combination requires a separate entry with all signatures and emergency contact.**
- **Maximum Tests per day** - Horses in this competition are limited to 4 **tests per day**.
- **Level Restrictions** - Horses may only compete in levels that are adjacent with the same rider. For example a horse may not be ridden in a basic level test and a level 2 test UNLESS with a different rider
- **Tests:** Current WDAA/USEF Western Dressage tests are available at www.westerndressageassociation.org.
- **Attire and Equipment:** USEF rules and guidelines will be used for attire and equipment. For more information please visit www.usef.org and [https://wdaa.memberclicks.net/assets/docs/WDAA Equipment and Attire Guide 2 22 2022.pdf](https://wdaa.memberclicks.net/assets/docs/WDAA_Equipment_and_Attire_Guide_2_22_2022.pdf)
- **Negative Coggins (within the 12 months of the show date) and vaccination record (Equine Influenza Virus and Equine Herpes Virus "Rhinopneumonitis" within 6 months of show date) are required to be submitted with entry or shown prior to unloading on show grounds.**
- **Deadline:** Entries must be received by the closing date. Make checks payable to **Kansas Dressage and Eventing Association** and send entry to Stacia Wert Gray, **entry** secretary. Credit cards through <https://www.horseshowoffice.com/> or paypal at kdeamain@gmail.com
- **Other**
 - Every horse/rider team requires a separate entry. Entry must be complete before receiving packet.
 - Entries are accepted as received by secretary. Entries may be limited. Entries arriving after closing will be accepted at the discretion of the show secretary as space allows.
 - If the classes are oversubscribed, a "wait list" will be maintained. Horses will be moved into the show based on wait list order prior to schedule. After the show has been timed, show secretary will work wait list horses into the show based on the best fit. Mgmt reserves the right to refuse any entry.
 - Horse, rider, owner USEF numbers are optional. If you are competing for USEF year-end awards, please provide these numbers.

B. Scheduling

- Management reserves the right to change officials, limit entries, combine or cancel classes, and modify the schedule to make any changes required by circumstances to the competition specifications listed herein.
- Show Management reserves the right to cancel classes insufficiently filled and to refuse or require withdrawal of an entry for cause deemed sufficient by Show Management
- Musical freestyle sound check will be late afternoon (exact time with ride times) on the June 16.

C. Official Ride Times

- **Provisional Ride Times:** Stabling assignments and provisional ride times will be available on www.horseshowconsulting.com/ about one week prior to the show. They will be emailed as well.
- **Day Sheet:** Be certain to check the day sheet which will be posted by noon the day before the show. It will reflect any last minute scheduling changes. The day sheet will be posted in the show office. The day sheet is the "Official Show Times" document.

D. Scores

- Tests will be scored in show office and scores will be posted on site. After the show, scores will be available on www.horseshowoffice.com.
- It is the responsibility of the competitor to verify the accuracy of all scores.
- Scoring errors must be reported to the Show Manager within one hour of the official posting of the scores from the last class of the show day during which the score was earned.
- Ties will not be broken.

- Each competitor is responsible for supplying management with correct applicable numbers (USEF/AQHA/WDAA) for horse, owner, rider, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

Facility Information

A. Stabling

- **Stalls:** Stalling is optional. 12 stalls, 10x10 in size, are available in indoor arena. Stall fee includes initial shavings. Floors are dirt.
 - **Shavings:** Additional shavings are available for purchase through the show office prior to the show or during the show for \$10/bag. Please, no straw bedding.
 - **Availability:** Stalls are available from 3pm the day prior to the show until 9 pm on show day.
 - **Tack:** Tack stalls are available for \$25.00 but they will have shavings/dirt in them, and will only be available if not needed for horse stalls.
- Groups:** Please note stalling groups with your entry. Show secretary is a lousy mind reader!

B. Arenas

- **Footing:** Outdoor competition arena is sand; warmup will be in the indoor arena with sand/dirt mix for footing.
- **Arena Size:** Small ring (20m x 40m) may be used for Introductory and Basic level tests. All other classes will be in the standard(20m x 60m) ring. All freestyles (including intro and basic level) will be in the 20m x 60m ring.
- **Schooling**
 - Horses may work in the warm-up and show arenas on Friday night between 7 and 8:30 pm and on Saturday after the schooling show ends (about 2pm)
 - Hand walking in the indoor show arena on show day is permitted at designated times. Warm-up is outside on grass or in dirt arena: lunging is available in designated round pen only.

C. Accommodations

- **Hotels:** Hotels in SE Wichita are the closest to the facility.
- **RV:** Self contained RVs are welcome to park on the grounds, but no electrical or water/sewer hookup is available.

USEF Rules

A **TRAINER**, as listed on the entry form, is defined as any adult (18 & older) who has responsibility for the care, custody or performance of the horse while the horse is on the competition grounds. This adult must sign the entry form as trainer. If the rider is considered the trainer, the rider must sign as the trainer. A parent or guardian signing on behalf of a junior exhibitor **must** be a USEF member. A **COACH**, as listed on the entry form, is defined as an adult (18 & older) who gets paid for instructing, teaching, schooling or advising a rider with their horse on the competition grounds. This adult must sign the entry form as coach. If there is no coach, the signature for coach may be left blank.

Membership/Non-Member/Proof of Membership fees (NEW RULES EFFECTIVE 12/1/2022)

All ACTIVE USEF members who are participants (rider, owner, trainer, agent, lessee, or coach) must provide to the competition secretary a current USDF membership number. In the event a rider or owner does not have his/her membership number, he/she must pay a \$45 USEF show pass fee. Riders and owners are only eligible for one show pass fee per competition year. Show pass purchases can only be made online through USEF by the rider or owner. Trainers and coaches, including parents signing an entry blank or acting as a trainer or coach, must be an Active USEF member and are NOT eligible to participate under a show pass and must be active USEF members.

Motorized Vehicle Rule: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF SAFESPORT TRAINING REQUIREMENTS TO COMPETE Effective January 1, 2019, every USEF adult member (18 & older) **with an active** senior competing membership must complete USEF's Safe Sport Training, overseen by the U.S. Center for SafeSport. An adult member may be OWNER, RIDER, TRAINER and/or COACH. Adult members listed on the entry must complete the entire course and be Safe Sport Trained before the first day of competition. Safe Sport Training must be completed by all adult members on the entry or the rider will not be allowed to compete. You may access the Safe Sport modules from your USEF member dashboard at www.USEF.org.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.
