#### Rules

- USEF rules will be followed for biting and saddlery.
- Running and Standing Martingales will be allowed in over fences classes.
- Riders must wear a hard hat and footwear with heels and must sign a liability release.
- Formal attire not required. Neat schooling show attire is sufficient.
- Safety is first in all activities. All Children age 10 and under must be supervised by an adult.
- No dogs.
- No refunds after closing date.

# **Oklahoma State Fair Requirements and General Information**

### A. Health certificate, admission tickets and arrival

- Health certificate (30 days) and a current coggins (12 months) necessary to enter the show grounds.
- Everyone (riders, owners, grooms, groupies, etc) must purchase an admission ticket at the prevailing rates. (See www.okstatefair.com). Admission tickets are the responsibility of the competitors. They will be available for purchase at the livestock entry gate 7 or can be purchased prior to 9/12 at a discount. Check the Oklahoma State Fair website for pricing and possible discounts.
  - Purchased in advance of Fair opening day: \$10 Adult 12 & older; \$5 Children 6-11; Children 5 & Under: Free
  - Purchased after Fair opens or at Gate upon arrival: Adult: \$15; \$10 Children 6-11; Children 5 & Under: Free
  - Wednesday, Senior Day (55+): Free (with I.D.)
- All Livestock enter through Gate 7, located just east of the intersection of Black Gold Drive and Geronimo Drive on the west side of the OKC Fairgrounds. The GPS address for Gate 7 3466 Black Gold Drive., Oklahoma City OK 73107. Gate 7 opens each day of the Fair at 6:30 a.m. and closes at 10:00 p.m. No arrivals/departures outside of those hours.
- Please leave your dog at home. They are not allowed at the OKC Fairgrounds.

**B. Stabling Information: All horses must stall.** Stalls are permanent and 10x10 on asphalt or cement floor with doors located in Barn 8. Stall fee **does NOT** include shavings. You can obtain bedding by contacting the State Fair Feed & Bedding office at (40S) 948-6786 and establishing an account with them prior to arrival or purchasing upon arrival. **Stalls are available Monday 3 pm until Tuesday 8:00 p.m.** Tack stalls are available. **Be sure to use a common group name if you would like to stable with your friends.**

- Warm-up is barn 7. Lunging is available in west covered arena.
